MOTION OF PETITIONERS THE STATE OF NORTH CAROLINA AND GOVERNOR ROY COOPER TO DISMISS THE CASE

Pursuant to Rule 46.2(a) of the Rules of this Court, the Attorney General of North Carolina, on behalf of Petitioners the State of North Carolina and Governor of North Carolina Roy Cooper (the "North Carolina Petitioners"), respectfully moves that the North Carolina Petitioners be dismissed as parties to this case. All fees due the Clerk have been paid, and the North Carolina Petitioners shall assume all costs owed by them. Petitioners filed the petition for a writ of certiorari in this case on December 27, 2016, and the petition is currently pending before the Court for consideration at its March 3, 2017 Conference.

These consolidated cases involve challenges to a set of North Carolina election-related laws, known as SL 2013-381, which eliminate same-day voter registration, reduce the State's early-voting period, preclude qualified voters from casting provisional ballots within their designated county, require in-person North Carolina voters to present certain forms of photo ID, and discontinue pre-registration of 16-year-olds who would reach qualifying voting age before the next election. The court of appeals held that the challenged aspects of SL 2013-381 violate Section 2 of the Voting Rights Act and the Equal Protection Clause of the Fourteenth Amendment to the United States Constitution. Since the filing of the petition for a writ of certiorari, the North Carolina Petitioners have decided that they no longer wish to seek this Court's review.

At this time, the movants do not include petitioners the North Carolina State Board of Elections, Kim Westbrook Strach, Joshua B. Howard, Rhonda K. Amoroso, Joshua D. Malcolm, Paul J. Foley, Maja Kricker, and James Baker (all in their official capacities). The parties will notify the Court of any changes in this regard.
