Over the past ten years, there's been a battle between the need for voter access and the prevention of voter fraud. Yet, when working to balance these important interests, there are often winners and losers. In advance of the 2012 elections, state legislatures have enacted a flurry of new laws requiring voters to show photo identification at polls, heightening registration requirements, imposing proof of citizenship laws, shortening early voting periods, and making it more difficult for ex-felons to exercise their right to vote. This symposium will ask the questions: How will these new laws impact the 2012 elections? Did states find an appropriate balance or have they gone too far? Finally, how should the Section 5 preclearance requirement of the Voting Rights Act play a role? Through a keynote address and panel discussion with scholars and practitioners in the field, we will address these complex policy and legal issues. Specifically, participants will present their findings and views on the impact of these laws on the 2012 elections and dissect the current movement's context in history and in today's turbulent political climate.
